ABORTION INDUSTRY HIDES THE REALITY OF FETAL DEVELOPMENT

In the era of fake news, it should come as no surprise that the abortion industry doesn't want women to see the truth of abortion or the stages of development of pre-born children.

Earlier this year, the pro-abortion Museum of Contraception and Abortion in Vienna, held a photography competition called Stock Photos on Abortion. According to their website, "the topic of abortion is still being exploited in public discourse: Polarizing and stigmatising media coverage patronizes and even criminalizes women. The media represents a one-sided visual language that projects a wrong impression of abortion and the circumstances of women affected by unwanted pregnancy... MUVS wants this initiative to contribute in a useful and important way to the further destigmatisation and decriminalisation of women with unwanted pregnancy and of abortion."

One of the pictures from the competition is pictured on the right. They say it's an image of a gestational sac at 6 weeks gestation. It is clearly a sac but what we don't see is what's inside the sac.

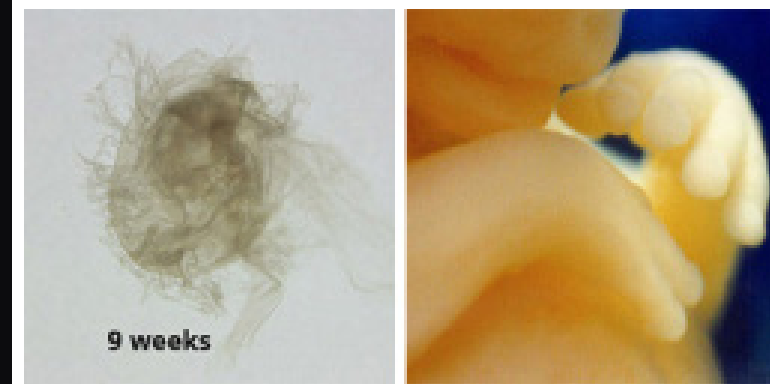
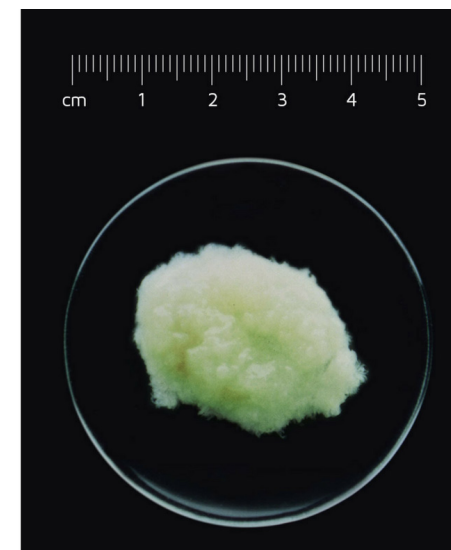

Women are being lied to about how quickly a pre-born child develops. Check out how those involved in the #abortion industry are trying to hide the truth

Early Options, an abortion facility in New York, has a fancy website featuring happy couples embracing. The facility advertises something it calls the "Soft Touch" method of abortion, which is a suction aspiration abortion using a hand-held syringe. In this type of abortion, a tube attached to a syringe is inserted into the woman's uterus, and the abortionist manually creates the suction by pumping the syringe. This pulls apart the preborn child, forcing her, often in pieces, from the woman's body.

The abortion facility calls this type of abortion "noninvasive" and "natural." There is, of course, nothing natural about inserting a tube into a pregnant woman's womb to suction out her developing child. Women's bodies are naturally designed to give birth, not to have their wombs invaded by medical instruments of death. Abortion, regardless of how it is done, is not a natural process.

On another page, the abortion facility gives information about fetal development in early pregnancy, but the facts and illustrations presented are very inaccurate, leaving out a great deal of information and distorting the reality.



The facility uses false depictions of abortions in an attempt to convince women that early abortion is trivial and easy, encouraging women to abort. Below are some of the ways the abortion facility misrepresents early abortion.

THE LATE 18TH CENTURY MEMBER of Parliament, William Wilberforce's fight against slavery, is aptly used to describe the fight to criminalize abortion. I would like to put a finer point on this illustration for the purposes of comparing fairly the strategy used by our two difficult causes.

Wilberforce attacked the slave trade and in spite of a twenty-five-year cultural and economic battle, he succeeded politically to end it. Twenty-five years later, slavery itself was outlawed. His determination is still a model of holy perseverance.

However, what Wilberforce did **not** do, was attack slavery by proposing that it be outlawed for women and children first, after which it would be easier to outlaw it for men. He did **not** suggest a strategy that proposed only children 12 and older could be sold into slavery until perhaps the age of 75, after which they should go free. **Nor** did he suggest that

pregnant women be exempted from slavery.

What Wilberforce **did** was to uphold the dignity of every human being, by strategically attacking an issue surrounding slavery: the slave trade.

Laws that recognize unborn victims of crime, or criminalize coercion to abort or offer protection from coercion for health care professionals, as well as motions that condemn the misogyny of sex selection abortion, or other related aspects that have stemmed from dehumanizing an unborn child, get our support. But we have not parsed out the humanity of the unborn child to be settled at a later date.

The next time you hear the Wilberforce strategy invoked as an example of successful strategizing for abortion, whole-heartedly agree. But clarify first what Wilberforce did **not** do. ■

DEMOCRACY BECOMING A FARCE

FROM THE VERY MOMENT of his election as the Liberal leader of Canada, Justin Trudeau started issuing orders curtailing the freedom of conscience of those aspiring to become Liberal members of parliament by prohibiting them from speaking in favor of the rights of the unborn child, along with similar controversial issues and beliefs of the Liberal leader. At the time of the election, it did surprise me that many believers, including practicing Catholics, decided to blindly 'obey' Mr. Trudeau, and to jump on the Liberal bandwagon.

Even since the big victory of the party, Prime Minister Trudeau seems to be acting against the Christian faith and particularly against the Catholic Church's tenets. Euthanasia became free for the asking in Canada. Abortion was proclaimed a "right" for women, and a condition for countries to receive Canadian International Assistance. With the definition of sex, additional "genders" were incorporated even against science. The definition of marriage as between a man and woman was legally redefined, and many other similar core values of believers in One God were overturned. Now the right to work is also being made subject to the denial of one's

freedom of conscious and religious beliefs. Who knows that the very freedom to worship will not be taken away tomorrow? All these big revolutions took place in Canada in the short period of two years' Liberal governance. There were not any or enough open and serious debates on these issues in Parliament.

Conscience issues and rights seem to be totally absent from Liberal thinking. Believers in Canada cannot be faulted if they think that the Liberal

members of Parliament have given up their faith in the one God and his Commandments. Surprisingly, they seem to be issuing commandments overriding God's commandments. Or perhaps they have redefined for themselves the commandments and articles of faith and practice, or they keep a silence in order to cling to power and its benefits, and subscribe to executive orders and one-man policy statements.

There is little future for a democracy when rulers set themselves above the people; when the party is above the electorate; when brute majority totally stifles the minority and the people's voice; and when leaders discard every dissenting voice. ■
