

nespite arguments that abortions 26 deaths of women in the U.S. from Umust be made "legal", i.e., unrestricted, in order to prevent backstreet abortions, women are now expected to have private, "backstreet" abortions in their own homes, without medical care. The pregnant woman swallows the drugs, endures the pain, the bleeding and the disposal of the child alone. Admissions of women to hospital emergency rooms have skyrocketed since DIY abortions became available. This is not surprising since the deliberate killing and expelling of the child from her body is a most unpleasant experience and a fundamentally unnatural act. Sepsis, haemorrhaging, and incomplete abortions are the result, as well as a dead child. According to a British report in 2020, more than 10,000 women required hospital care after a DIY abortion.

A study released in November 2021, by the U.S. based Charlotte-Loisier Institute found that abortion-related emergency room visits following the abortion pill regime increased more than 500% between 2002 - 2015. It is known that there were at least

chemical abortions.

Complications of abortion, whether from surgical or DIY abortions, are not reported by women in hospital emergency rooms, who claim instead that they have had a "miscarriage". Without proper information on the real source of the emergency there is an increase in risk for women, leading to an increase in the number of hospitalizations.

THE FALL OF ROE: A SIGN OF HOPE

ro-Lifers around the world the celebrated recent overturning of *Roe v Wade* in the United States. This decision effectively ended 49 years of abortion on demand in America and gave each state the freedom to decide whether or not they will protect life. At the time of this writing numerous states have outlawed abortion, resulting in the saving of countless lives. Although this decision is not binding in Canada, it does give pro-lifers here hope and a renewed focus.

We are all too aware there is still a long road ahead before obtaining full protection for all human lives in the womb, as many states will retain the status quo.

Cambridge Right to Life was contacted by the online resource, Cambridge Today for comment on the decision and we shared following statement: Cambridge Right to life is thrilled that a majority decision was found by the US Supreme Court Justices who recognized that Roe was



"egregiously wrong from the start," and like Canada there was never a constitutional "right" to abortion. We hope the effects of this momentous decision trickle into Canada in which our nation will one day recognize the harm abortion has done to women and society, and thus restore legal protection to the preborn child in the womb. We work toward a future where every woman has the support and resources she needs to bring her child to life. Women deserve better than abortion.

Prime Minister Trudeau called the reversal of *Roe v. Wade* "horrific." He

has long claimed that women have a constitutional 'right' to abortion under the Charter, but in reality, "abortion rights" are nowhere to be found in the Charter.

Abortion is permitted in Canada due to the legal definition of when one becomes a human being.


Section 223 of our Criminal Code states:

A child becomes a human being within the meaning of this Act when it has completely proceeded, in a living state, from the body of its mother, whether or not

> (a) it has breathed; (b) it has an independent circulation; or (c) the navel string is severed.

This antiquated definition rejects the scientific and biological reality of when a new human being comes into existence and thus denies legal personhood until a child is born alive.

According to BC lawyer, Charles Lugosi, "the Supreme Court of Canada had an opportunity in the Mary Wagner case to decide the question whether Parliament's law was constitutional or not, and without reasons anonymous judges refused to hear her case, despite meeting the Court's own test for an issue of national importance. The obvious inference is that the Court was afraid to hear the case, because facing the truth would have required the court to declare all abortion in Canada illegal and

nays after the US Supreme Court overturned *Roe*, and the same evening a pro-abortion protest rally organized by the Shore Centre (formerly Planned Parenthood of Waterloo) took place in Kitchener, our office was a target of vandalism. The perpetrator grafittied the words, "Abortion is a human right." This false statement is the song-sheet of pro-abortion advocates. Of course their mantra is the antithesis of what is commonly understood as fundamental rights. The universal declaration of human rights states: "Human rights are rights inherent to all human beings, regardless of race, sex, nationality, ethnicity, language, religion, or any other status. Human rights include the right to life and liberty, freedom from slavery and torture, freedom of opinion and expression, the right to work and education, and many more. Everyone is entitled to these rights, without discrimination."

The disregard and contempt for the human rights of preborn children in the womb have resulted in the allowance of the barbarous tortue of the most vulnerable member of the human family by the millions.

Of course, this is not the first time we have experienced this kind of vandalism but we've observed that since the



overturning of Roe, abortion advocates have become completely unhinged both in the US and in Canada. Several pro-life pregnancy centres and churches in

the US have recently been attacked and fire-bombed. A group called Jane's Revenge claimed responsibility for some of the attacks, many of which had the spraypainted message "If abortion isn't safe, neither are you!" Jane's Revenge called for a "night of rage" on the day *Roe* was overturned. They posted an online message on their social media stating, "We offered an honourable way out. You could have walked away. Now the leash is off. And we will make it as hard as possible for your campaign of oppression to continue. We have demonstrated in the past month how easy and fun it is to attack. We are versatile, we are mercurial, and we answer to no one but ourselves. We promise to take increasingly drastic measures against oppressive infrastructures," saying "those measures may not come in the form of something so easily cleaned up as fire and graffiti." While the protest in Kitchener was peaceful, one can't help but wonder if similar rhetoric contributed to the local criminal activity.

Abortion advocates in Canada are exploiting the Roe decision by claiming, once again, that abortion access is sorely lacking.

Angelica Vecchiato, Campaign Life Coalition Intern reported that, "Here in Canada abortion advocates are now concerned that with Roe overruled, Canada will somehow soon become an imaginable, nightmarish dystopia: a country where babies are not killed in the womb. Kelly Bowden, director of policy and advocacy at Action Canada, said that she advocates for a "wait and watch" approach to see if there will be a spillover effect to the overturning of Roe V. Wade in Canada, commenting that "The actual numerical impact of [Roe v. Wade] is yet to come in the U.S. as well as, enshrined right here in Canada is that Canadians continue to face barriers to access here. So, we also need to concentrate on ensuring that our system is strong and that the universal health care of abortion which we are granted as a convenience is actually accessible here as well." In other words, even though abortion is permitted in Canada throughout all nine months for any and no reason at all, paid by the taxpayer, and every attempt at discussing legal protection for children in the womb is often shut down before a proper debate can take place, according to Canadian abortion activists, now is the time — more than ever — that Canada should double down on abortion accessibility." Vecchiato continues, "It looks like pro-choicers are nervous, maybe even scared because they know it's coming. The tide is turning on abortion. So now is the time for pro-lifers to ride the wave, to use the momentum to our advantage."
